# PRIME MINISTER'S DAY

A meeting of Ministers had begun at 10 a.m. Present:

Prime Minister

S/S for Employment Chief Secretary, Treasury Minister of State, Industry (Adam Butler)

The meeting, which lasted about 35 minutes, was to take stock of the steel situation.

Later this morning the Prime Minister would be paying an informal visit to the Department of Trade.

At 1600 hours the Prime Minister would have tea with the Prime Minister of Mauritius, Sir Seewoosagur Ramgoolam, who was here on a private visit following the recent Socialist International in Vienna. This evening the Prime Minister would present an award to the MP who raised the most money at a recent sponsored "swim in" in aid of research for Spina Bifida. ### IN THE HOUSE

#### STEEL

Correspondents could assume that at this morning's meeting the Prime Minister had received a report on the settlement with steel unions (reported yesterday) - with the exception of ISTC and NUB - the Hadfield situation and ACAS' efforts to get in touch with Mr. Sirs and Mr. Smith. The Government could be described as being a little more hopeful but, of course, ISTC and NUB were the two important unions. We could throw no light on a court of inquiry. Yesterday's settlement seemed to rule out the need for one.

We could not confirm whether or not Sir Geoffrey Howe had consulted colleagues on the speech he made in Taunton at the weekend.

We confirmed that the working document was expected at the end of this week/early next week.

The morning Lobby was repeated.
