LPS VISIT: MEETING WITH JI PENGFEI: FUTURE OF HONG KONG

- 1. AT HIS MEETING WITH VICE PPEMIER JI PENGFEI ON 5 JANUARY
 THE LPS RECALLED THAT YOU BROUGHT UP THE SUBJECT OF THE FUTURE
 OF HONG KONG DURING YOUR VISIT LAST YEAR. MR ATKINS SAID THAT
 IN A COMPARATIVELY FEW YEARS' TIME ALL THE LAWS AND POWERS
 WHICH AT PRESENT EXISTED IN HONG KONG WOULD COME TO AN END IF
 NOTHING WAS DONE. THIS QUESTION WAS ALREADY THE SUBJECT OF MUCH
 DISCUSSION IN HONG KONG. THE LPS BELIEVED THAT IT WAS THE WISH
 OF BOTH SIDES THAT CONFIDENCE IN HONG KONG BE MAINTAINED. WE
 WERE GIVING MUCH THOUGHT TO THIS SUBJECT AND THE LPS BELIEVED
 HE SHOULD DRAW THE MATTER TO THE ATTENTION OF PREMIER ZHAO THE
 FOLLOWING DAY.
- 2. VICE PREMIER JI SAID THAT THERE WERE STILL 15 YEARS TO GO.
 IT WAS AN IMPORTANT QUESTION AND THE CHINESE WERE NOW THINKING
 OF STUDYING THE MATTER SOON. A DECISION ON HONG KONG SHOULD NOT
 OF COURSE WAIT FOR 15 MORE YEARS. HE COULD ASSURE THE UK SIDE
 THAT IN THE FUTURE CHINA WOULD PRESERVE THE INTERESTS OF
 'EXISTING INDUSTRIALISTS AND BUSINESS CIRCLES'. HOW THIS
 SHOULD BE DONE WAS A MATTER WHICH WOULD SOON BE PUT UNDER STUDY.
- 3. JI SAID THAT DOMESTICALLY CHINA NOW ADVOCATED AN OPEN DOOR POLICY. THEY HAD ESTABLISHED SPECIAL ECONOMIC ZONES IN SHENZHEN AND ELSWHERE. RELATIONS BETWEEN HONG KONG AND THE MAINLAND WERE DEVELOPING WELL. INVESTORS SHOULD NOT WORRY. THEY WOULD STILL BE ABLE TO MAKE MONEY IN HONG KONG. CHINA WOULD NOT TAKE MEASURES SUCH AS THOSE TAKEN IN THE EARLY YEARS OF THE REVOLUTION WHEN THEY HAD CONFISCATED PROPERTY. THEY WOULD NOT CONFISCATE CAPITALISTS' ASSETS IN HONG KONG. IN THE FUTURE THE TWO SIDES COULD CONDUCT TALKS ON THIS MATTER AND EXCHANGE VIEWS.
