DEAR KENNETH,

ONCE AGAIN I WANT TO EXPRESS MY DEEP APPRECIATION AND ADMIRATION FOR YOUR CHAIRMANSHIP OF THE COMMONWEALTH HEADS OF GOVERNMENT MEETING. IT WAS DUE IN LARGE MEASURE TO YOUR HANDLING OF THE DISC-USSIONS THAT THE OUTCOME PROVED TO BE SO CONSTRUCTIVE. IT MUST NOW BE THE HOPE OF ALL OF US THAT IT WILL POINT THE WAY TO GENUINE BLACK MAJORITY RULE IN RHODESIA AND A RETURN TO PEACE AND LEGALITY THERE .

A COPY OF THE INVITATION TO A CONSTITUTIONAL CONFERENCE IN LONDON IN EARLY SEPTEMBER WHICH WE ARE SENDING TO BISHOP MUZOREWA AND THE LEADERS OF THE PATRIOTIC FRONT COMES WITH THIS LETTER. AS YOU KNOW, WE ARE UNDER NO ILLUSIONS ABOUT THE DIFFICULTIES THAT LIE AHEAD.
