Could I at all persuade you to stop over a little longer, perhaps rest for the night after such a long and tiring journey, if your itinerary and commitments make it possible for you to do so?

I enclose an advance copy of a letter from Mrs Gandhi to the Prime Minister (the signed copy will be sent on to us by India House as soon as it is received).

You will see that Mrs Gandhi is suggesting that the Prime Minister extend her stopover at New Delhi in the course of the night of September 28/29 so that the two can meet. The time of the Prime Minister's arrival at New Delhi is dictated by her programme in Hong Kong; this is already fairly tight and it would cause disappointment there if arrangements which are going ahead had to be altered. It therefore seems that the only way to meet Mrs Gandhi's proposal would be for the Prime Minister to arrive at Delhi at 12.30 am as planned and to spend the rest of the night at the High Commissioner's residence (fortunately it is a car journey of only 20 minutes or so from the airport); then she could have, say, a working breakfast with Mrs Gandhi before continuing her journey to London. Assuming an 8 am breakfast her amended ETA in the UK might be about 1900 hours on 29 September instead of 1125 hours.

From the point of view of our relations with India, we would hope that the Prime Minister might agree to Mrs Gandhi's request unless there are overriding reasons why she has to be back in the UK at the originally scheduled time on 29 September. The fact that Mrs Gandhi has gone to the pains of sending a personal message indicates the importance she attaches to keeping up her personal relationship with the Prime Minister. This is all to the good. MrsGandhi will no doubt be greatly interested to hear something of the Prime Minister's impressions of her discussions in Peking at first hand in view of the significance for India of China and recent moves to improve Sino-Indian relations.
