Rees (now acting leader of Com? for Foot, ill with shingles) wants to put down motion for select Com today. We discussed. The only alternative Tribunal under Act 1921. Disadvantages of this procedure. Boothby precedent (Session '40-'41). Publish evidence & report simultaneously. Evidence must be in toto not selected (cf Churchill's privilege Complaint 1935 re Hoare & Derby). Terms of reference to be limited to Porton association and allegations Observer & Mirror. No roving Commission outside. Socialist Worker article contains no material for enquiry tho' additional names, but these only 'interviewed by police'. Necessity for Counsel to represent (cf Boothby). Associate persons as well as Companies (cf Dan Smith who acted as Porton's paymaster). Stewart unsat as chairman. Walker Smith preferred, Havers not acceptable (in Con Govt as S.G.), though clearly keen. Betty Harrie Freedom? Page? Patrick Mayhew. Leon Britton? Richard Wood. Committee to be of 10 4+4+1+1. (see no reason for last one). Note opposite in Atkins meeting last night.
