Proposed Business for the Week 9th-16th February

On Monday, 9th February, there would be Frivate Members' Motions, the Motions being those of Mr. Newens on Foreign Policy and Morality (Mr. Hurd) and of Mr. Carter on The Need to Establish Industry as the Country's First Priority (Mr. King). This would be followed by a Motion on the Select Committee on Abortion (Mr. Jenkin) on which there would be a free vote.

On Tuesday, 10th February, Mr. Douglas-Mann would seek leave to introduce his Criminal Appeal (Amendment) Bill under the 10 Minute Rule, This would be followed by the Second Reading of the Dock Work Regulation Bill (Mr. Prior, Mr. Hayhoe).

On Wednesday, 11th February, Sir John Langford-Holt would seek leave to introduce his Shops (Amendment) Bill under the 10 Minute Rule and this would be followed by a half Supply Day, with subject to be decided. At 7.00 p.m. there would be Opposed Private Business: the Second Reading of the West Midlands County Council 3il on which Mr. Speed would intervene from the Front Bench.

on Thursday, 12th February, there would be the Second Reading of the Water Charges Bill, (Mr. Speed, Mr. A. Jones) and this would be followed by Motions on EEC Documents on Agriculture (Mr. Pym.)

On Friday, 13th February, there would be Second Readings of Certain Private Members' Bills, the first three bills being Mr. Corbett's Sexual Offences (Amendment) Bill, Miss Richardson's Domestic Violence Bill and Mr. Callaghan's Chronically Sick and Disabled Persons (Amendment) Bill.

On Monday, 16th February, there would be the Second Reading of her Fair Employment (Northern Ireland) Bill (Mr. Neave, Mr. Biggs-Davison), and of the Road Treffic (Drivers' Ages and Hours of Work) Bill (Mr. Fowler).

It was agreed that we would support the Scottish Nationalist Motion to reduce the salary of the Secretary of State for Scotland the following evening, Thursday 5th February, on a two line whip, but that we should not vote on Plaid Cymru's Motion that same evening. evening.

Mrs. Thatcher reported on a remark made by Mr. Cyril Smith on television the previous evening relating to the Conservative Party, and on a statement that had been made that day in reply by Mr. Atkins. It was exceed that, while supporting Mr. Atkins' statement and seeking to set the record straight, we should avoid making any statements in public about the Press reports relating to the Liberal leader.

Mr. Pym reported on a possible new clause to be introduced by the Government into the Agriculture (Miscellaneous Provisions) Bill on hereditary tenancies which might threaten property rights, generally. It was agreed that we should watch developments very carefully and that Mr. Pym would report when further details were able:
