AS WE HAD OF COURSE EXPECTED, THE TEXT THAT I BROUGHT BACK FROM BUENOS AIRES WAS NOT ACCEPTABLE TO THE BRITISH. WE ENCOUNTERED THEIR STRONG RESISTANCE IN THOSE AREAS WHICH I HAD PREDICTED TO YOU.
