On Wednesday, 24th November there would be the State Opening of Parliament followed by the Debate on the Address, which would be continued on Thursday, 25th November, Friday, 26th November and Monday, 29th November.

#### Matters Arising on Business 2.

It was noted that there was pressure in the Government to drop the whole Aircraft and Shipbuilding Nationalisation Bill for this Session if the Lords continued to stand firm on the cor this description of ship repairing companies from the scope of the Bill, and to seek to reintroduce it next Session using the Parliament Act to override the Lords' veto. There was a discussion on what our response might be, and the following points were agreed:

If, in the event of the Government dropping the Bill, certain shipbuilding companies encountered financial difficulties, we should be able to point out that the dropping of nationalisation in no way prevented the Government from being able to aid them if this was thought to be necessary.

(ii) The Lords would stand firm on the exclusion of ship repairing companies.

Mrs. Thatcher reported that the Prime Minister was continuing to refuse to permit the subject of the under-representation of England and Northern Ireland to appear on the Agenda for this Conference. There was a short discussion, and it was exceed that while we did not agree on the Agenda, we would nominate Numbers to take part in the Conference and would reserve the right to raise the question of under representation during the course of the proceedings.

### 4. Voting

There was a short discussion on the question of voting at the end of the debate which had been taking place that afternoon on whether to refer to the Privilege's Committee a matter which the Speaker had ruled to be a prima facie breach of Privilege. It was agreed that, in accordance with the convention that the Opposition Front bench normally supported such a reference once the Speaker had so ruled, members of the Shadow Cabinet would vote with the Government.

## 5. Future Business

There should be a full discussion on how we would vote on the Second Reading of the proposed Bill in the next Session to set up Assemblies in Scotland and Wales. This would take place after the discussion on the Queen's Speech at the next meeting on Tuesday, 23rd November. Mr. Whitelaw would circulate a paper.
